FOREWORD

This GASPÉ OF YESTERDAY article on Forillon Deeds by the Notary Public, Martin Sheppard, will serve to recall some of the people and events in the relatively isolated Guernsey settlements of Gaspé Bay in the 1830's.

Martin Sheppard, who was of Guernsey descent, was introduced in a previous article of this series published in SPEC on July 30th.,1985. On his visits to the Forillon communities he must have felt an affinity with his fellow countrymen.


Gaspesians are fortunate in having a remarkable record of the Forillon and its people in the books of Dr.John M. Clarke-


Dr.Clarke lived with and visited among the folk of the Forillon fishing coves and wrote of his experience with rare insight, sensitivity and appreciation. As example, of one such home, that of John Bichard, he wrote-

"...Such independent, versatile artisans these Guernseymen: Their homes are not shacks, shanties, lean-tos or wickiups, but well-carpentered, double or triple skinned, clapboarded and shingled houses with many windows and well-paneled doors. John Bichard drove every nail and dowel, fastened every board, made every window sash and paneled door; in other words he built his house with his own hands and took vast pride in it. Bichard was not a house-smith but a fisherman; but the old-time fisherman of this coast was prepared for every emergency, put his faith in the sea and his neighbours, lived without doctors and died well-ripened without drugs...."

To put these Deeds in perspective it should be remembered that, though Martin Sheppard was the first resident Notary Public in Gaspesia, the Guernsey families of the Forillon had been settled in Gaspé Bay from the 1780's and that over some four decades many interesting Deeds must have been "Done and Passed" before local Justices of the Peace. Unfortunately, such Deeds do not appear to be on record. Perhaps, tucked away in Gaspesian attics or cupboards are old, yellowed documents of incalculable social and historical value. Much has been lost but for that which remains efforts should be redoubled to search out, record and preserve such evidence of our Gaspesian heritage.

THE PROPERTY

A lot of land with a frontage of half arpent starting in front sixty yards from the top of the Cape on the East side of Lot No.1, located and situated at Indian Cove, the property of the said vendors and on which they reside, and running in depth to the limit (extremité) of the said Lot, which limit the said vendors are not now able to able to state - the aforesaid land with frontage of half arpent and depth of the the said Lot thus sold being bounded as follows, that is to say: In front by the remainder of the front of the said Lot No.1, running to the edge of the Cape; on the East side by a Lot claimed by Helier Lemesurier; on the other side, to the West by the remainder or other portion of Lot No.1, occupied by the said vendors and to the rear by unconceded land running North sixty degrees East magnetically, in accordance with the Certificate by Henry O'Hara, Esquire, as sworn to July 14th.,1819.

- . The vendors to build and erect, at their expense, a bridge sufficient to allow the purchaser to come and go freely from and to his lot and to the shore.
- . The said Thomas Lemesurier or his heirs would require the consent of the vendors, in writing, before selling this lot and its right of roadway and bridge.

PROPERTY DONATED

A certain portion of land with a frontage of 252 feet (English measure) and with the ordinary depth of the lands in Gaspé Bay (which depth the said parties are not able to state) being the North West part of the unnumbered Lot of land belonging to the said donors, located and situated at Indian Cove. The said portion of land thus given being bounded on the front by the sea, on the South West side by the other part of the said Lot of the donors, the frontage being 450 feet, English measure by the depth of the said Lot, and on the North West side by unconceded lands in their natural state, to the rear, in depth, by unconceded woodlands of the Crown..... With the habitable house located above that occupied by the donors and other buildings constructed and erected on the said portion of the said Lot, excepting only the house presently occupied as a home by the said donors and family and the land on which the said house stands.

The said lot thus donated by the said donors having been in their possession for more than thirteen consecutive years, without interruption.

Transaction and Agreement by and between Mr. Joshua Deniss, acting for himself and for Mr. John Mourant of Guernsey, formerly trading together under the firm of MOURANT AND DENISS, to and in favor of Messrs John Vaudin, Thomas Snow and Pierre Bienvenu of the Island of Guernsey per Mr. Francois Ahier, their Attorney.

THE DEBT

Joshua Deniss, Farmer and Fisherman, residing near St.George's Cove and John Mourant of the Island of Guernsey had formerly been in business as the firm of MOURANT AND DENISS. Their firm owed money to Messrs Vaudin, Snow and Bienvenu who had Powers of Attorney issued in Guernsey and sent to their Attorney in Gaspé Bay, Francois Ahier, Merchant, of St.George's Cove, to recover the debt.

Ahier obtained judgment in His Majesty's Provincial Court in the principal sum of \pm 190 s.3 p.5 I/2p.1 and interest thereon of \pm 39 s.2 p.1

Faced with this judgment and fearing the loss of his property Joshua Deniss agreed to repay the debt in two equal amounts in the years 1831 and 1832.

Pierre Lemesurier, Merchant Trader of St.George's Cove agreed to act as security for repayment by Joshua Deniss.
